| Comments: MISSISSIPPI AUTHORITY FOR EDUCATIONAL TELEVISION (MAET) IS THE LICENSEE OF EIGHT PUBLIC TELEVISION STATIONS SERVING THE STATE OF MISSISSIPPI. MAET CEASED ANALOG OPERATIONS FOR ALL OF THESE STATIONS ON FEBRUARY 17, 2009. SIX OF THESE STATIONS ARE OPERATING WITH FULL AUTHORIZED APPENDIX B FACILITIES AND THEREFORE HAVE NO FURTHER DTV ON-AIR OBLIGATIONS OR REPORTING REQUIREMENTS. HOWEVER, INASMUCH AS MAET OPERATES STATE NETWORK FACILITIES, ALL OF ITS PROGRAMMING, INCLUDING DTV CONSUMER EDUCATION INFORMATION, IS AIRED THROUGHOUT THE STATE ON ALL OF ITS STATIONS. IN PAST QUARTERS, MAET AIRED DTV INFORMATIONAL PROGRAMMING FAR IN EXCESS OF THAT REQUIRED BY THE COMMISSION; FOR EXAMPLE, AS REPORTED IN ITS LAST FORM 388, THE LICENSEE AIRED NO FEWER THAN 16 INFORMATIONAL 30-MINUTE PROGRAMS. MAET ALSO AIRED 30 MINUTES PER MONTH IN PRIME TIME ANNOUNCEMENTS, WHICH WAS SIGNIFICANTLY MORE THAN THE REQUIRED 22.5 MINUTES. AS FURTHER REPORTED IN PRIOR FORM 388S AND IN THE INSTANT FILING, MAET HAS OTHERWISE PROVIDED EXTENSIVE COVERAGE OF THE DTV TRANSITION AND JUNE 12TH DEADLINE FOR THE PUBLIC BENEFIT. NO DOUBT IN PART DUE TO THIS EFFORT, THE STATE'S CONVERTER BOX PARTICIPATION RATE EXCEEDED THE NATIONAL AVERAGE. UNFORTUNATELY, DUE TO A MISUNDERSTANDING OF THE FCC'S REVISED REQUIREMENTS APPLICABLE DURING THE PERIOD FOLLOWING ANALOG TERMINATION TO STATIONS OPERATING WITH LESS THAN FULL AUTHORIZED FACILITIES, MAET NEGLECTED TO AIR THE LAST REQUIRED 30-MINUTE PROGRAM AND, TOO, NEGLECTED TO MODIFY ITS ON-AIR ANNOUNCEMENTS TO INCLUDE REQUIRED | | | | | |

ANTENNA, SCANNING AND HELP CENTER INFORMATION. (MAET DID AIR BASIC CONSUMER EDUCATION SPOTS AS REQUIRED.)

IN ANY EVENT, MAET'S EFFORTS TO EDUCATE THE PUBLIC ABOUT THE DTV SUCCEEDED. A TOLL-FREE TELEPHONE BANK WAS SET UP AND MANNED BY STAFF ON FEBRUARY 18, 19, AND 20 FOLLOWING THE ANALOG SIGNAL SHUT-OFF. A TOTAL OF 57 CALLS STATEWIDE WERE RECEIVED FROM VIEWERS DURING THIS THREE-DAY PERIOD. THE DTV TOLL-FREE TELEPHONE LINE CONTINUES TO REMAIN ACTIVE AND RESPONDS TO VIEWERS' QUESTIONS REGARDING THE DIGITAL TRANSITION. DURING THE MONTH OF APRIL, MAET RECEIVED 10 CALLS (6-SIGNAL LOSS; 4-CONVERTER BOX). DURING THE MONTH OF MAY, MAET RECEIVED 16 CALLS (6-SIGNAL LOSS; 10-CONVERTER BOX). DURING THE MONTH OF JUNE, MAET RECEIVED 38 CALLS (18-SIGNAL LOSS; 20 CONVERTER BOX). IN TOTAL, MAET RECEIVED A GRAND TOTAL OF 64 CALLS DURING APRIL, MAY, AND JUNE. THIS EVIDENCE DEMONSTRATES THAT, BY ANY MEASURE, MAET'S AUDIENCE WAS WELL INFORMED OF THE DTV TRANSITION AND IN FACT TRANSITIONED SUCCESSFULLY INTO A DIGITAL-ONLY BROADCAST ENVIRONMENT.
